

ChartFields Distribution Examples Overview

This Job Aid provides various scenarios related to Payroll processing in Cardinal. If ChartFields are not entered on the Timesheet, Cardinal distributes Payroll charges based on the employees' Position/Department Default Funding.

For more information regarding Position/Department Default Funding, refer to the Job Aids titled HR351_Department and Position Default Distribution and HR351_Employee Class Overview. These Job Aids are located on the Cardinal website in Job Aids under Learning.

This Job Aid covers five scenarios related to distributions:

- Scenarios one through four provide simplified distributions and do not represent expected fringe expenditure or employee deductions
- Scenario five is an example that includes fringe expenditure and employee deductions

For information regarding overtime processing, refer to the Job Aid titled **TA372_Overtime Lag**, which is located on the Cardinal website in **Job Aids** under **Learning**.
