Timesheet Exceptions Overview

This Job Aid provides a list of Timesheet Exceptions that could be generated in Cardinal Time & Attendance after the Time Administration process runs.

Once time is submitted online or interfaced to Cardinal, hours are processed by the Time Administration process in an automated batch process that will run multiple times each day.

The Time Administration process checks submitted time against business rules to validate that the time is accurate. The process will generate a variety of Timesheet Exceptions which may require Agencies to take action.

While the TL Supervisor is responsible for ensuring that all Timesheet Exceptions are resolved or allowed as appropriate before approving the time, TL Administrators should review Timesheet Exceptions to make sure, at a minimum, no high Timesheet Exceptions exist before time is loaded/distributed by payroll.

- No Timesheet Exceptions: Submitted time becomes payable time with no Timesheet Exceptions
- Low or medium severity Timesheet Exceptions: Submitted time becomes payable time with low or medium Timesheet Exceptions
- High severity Timesheet Exceptions: Submitted time does not become payable time with a high severity Timesheet Exception. Once corrected, the Time Administration process will clear the Timesheet Exception and the time becomes payable time

Note: Only high severity Timesheet Exceptions prevent processed time from becoming payable time, but all Timesheet Exceptions should be reviewed and corrected.

The list of Timesheet Exceptions provided in this Job Aid are ordered by severity (from Low to Medium to High) followed by a description of the Timesheet Exception.
