



Combination Edits Review Tools Overview

Combination Editing is a feature in Cardinal that helps to maintain data integrity across all modules. Defined combinations of ChartField values are established and used to check journal entry lines in General Ledger and the other Cardinal modules.

The three components of the Combination Edits are:

1. **Combination Definition:** defines the ChartFields that are required or optional in the combination edit. For example, a Combination Definition may require an Account and a FIPS code be defined on each Journal Line.
2. **Combination Rule:** defines the valid values of the ChartFields that are named in the Combination Definition. In other words, the Combination Rule defines the specific values of each ChartField that will or will not pass the editing process for a Combination Definition.
3. **Combination Group:** links the Combination Rules that are to be applied as a group during the edit process. All rules within a group must have the same Combination Definition. ChartField combination editing compares the values entered in Cardinal to the Combination Definitions and Combination Rules that are defined.

Typically, the Combination Edits are set up under the **SetID** of "STATE". However, there could be exceptions. For example, the Combination Edits that are set up for Virginia Department of Transportation (VDOT) are all established under the SetID of "50100". Additionally, users do not typically make changes to ChartField combinations; these instructions are designed to assist when a user obtains a combination error on a journal line.

There are two tools that can be used to review the Combination Rules and help identify the cause of a Combination Edit Error. These tools are the **Review Combination Data** page and the **ChartField Combination Editing Rule** Report.

Navigation Note: Please note that there may be a **Notify** button at the bottom of various pages utilized while completing the processes within this Job Aid. This "Notify" functionality is not currently turned on to send email notifications to specific users within Cardinal.

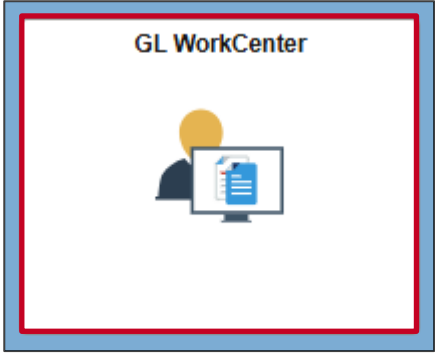

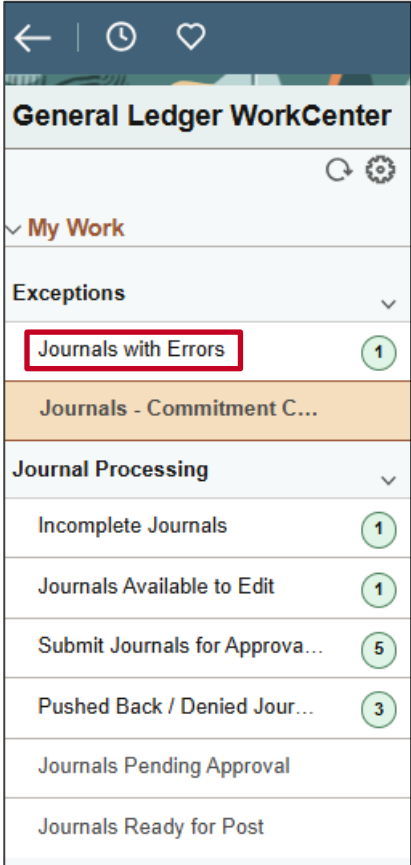
Receiving a Combination Edit Error

When a Combination Edit error occurs, the error message identifies the Combination Group which was violated by a specific ChartField string. The Combination Group can be used to identify the associated Combination Rule.

Combination Edit Error Example

For example, lines numbered 1 and 2 of the journal below have a Combination Edit error relating to the Cost Center/Fund in group CSCFUND. This message gives the specific Combination Group but not the Combination Rule.

Step	Action

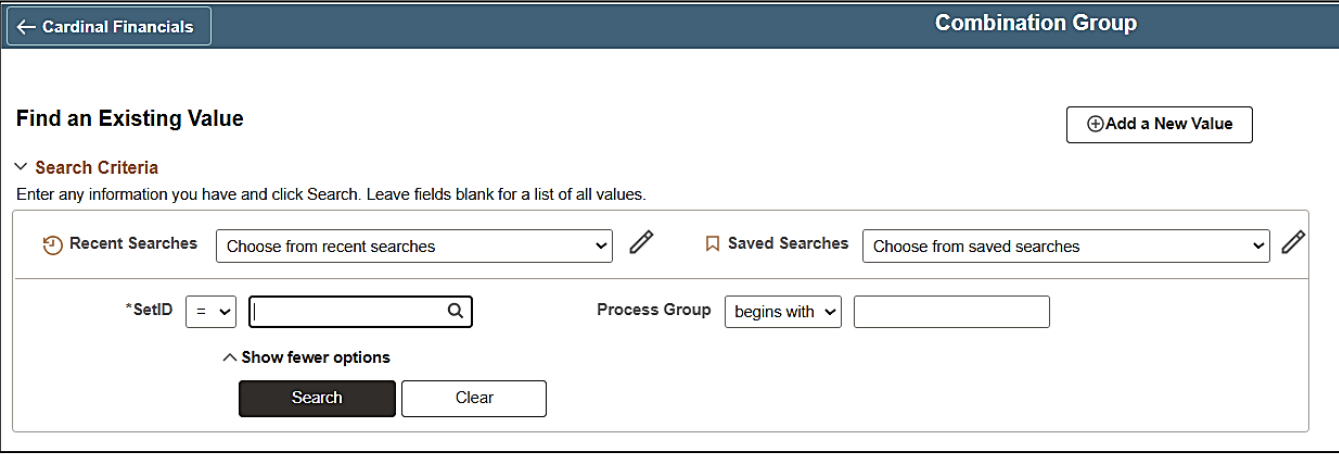
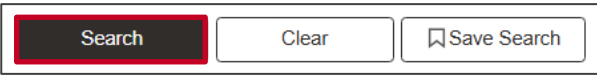

In this example, the error relates to the Cost Center/Fund (i.e., Combination Rule "CSCFUND"). Knowing the Combination Rule will assist in narrowing the data that is pulled when running the Review Combination Data Inquiry and will enable users to use the ChartField Combination Editing Rule Report.								

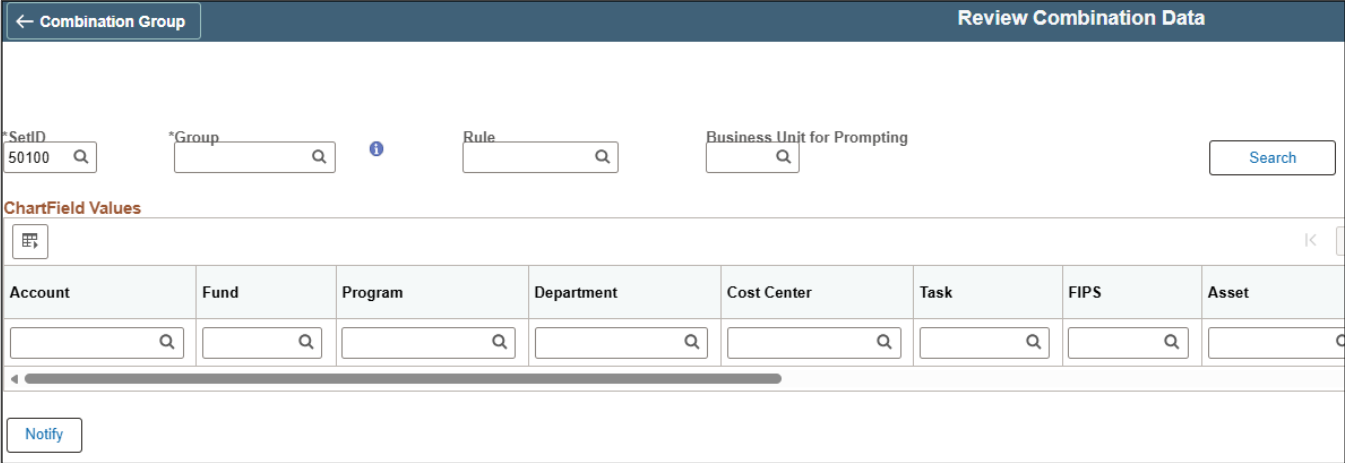
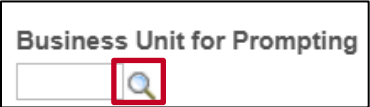

Overview of the Review Combination Data Page

This page is used to retrieve data relating to valid ChartField combinations that have been entered and built in the system during Cardinal's overnight batch processing. If a new combination is created, it will not appear in this inquiry until after the build process is run overnight in Cardinal.

Step	Action
1.	Navigate to the Review Combination Data page using the following path: NavBar > Menu > Set Up Financials/Supply Chain > Common Definitions > Design ChartFields > Combination Editing > Review Combination Data The Review Combination Data page displays. 
2.	Click the Group Look up icon and select the applicable Group. 
3.	Click the Rule Look up icon as needed and select the applicable Rule. If this field is left blank, every Rule under that Group is retrieved. 
4.	Click the Business Unit for Prompting Look up icon and select the Business Unit associated with the Group.

	If the value in the Number of Rows Retrieved field is greater than the value in the Max Rows Displayed field, click in the Max Rows Displayed field and update the number to equal the value in the Number of Rows Retrieved field. Click the Last link to update the row count. If the value in the Number of Rows Retrieved field is equal to or less than the value in the Max Rows Displayed field, proceed to the next step.
8.	User can extract data from this page into an Excel document. Click the Download icon. 
9.	Open the Excel file once downloaded.
